VITA

Mr. Thon Thamrongnavasawat was born in Bangkok on December 6, 1966. He finished his high school education from Chulalongkorn Demonstration School in 1984. He graduated with the degree of Bachelor of Science from the Department of Marine Science, Chulalongkorn University in 1988, then he continued his master study for a Master Degree in Marine Biology at the same department.

His first field of study is zooplankton in the reef which was the study tropic for his special problem for Bachelor Degree. He started to examine the reef morphology and developmental stage when he was a field staff of ASEAN-Austral Coastal Living Resource Project in 1988. In 1989 he began to study remote sensing for coral reef and seagrass studies. During his analysis he presented a few publications about remote sensing studies on coral reef and seagrass ecosystems in Thailand. One of these studies was financed by the Science and Technology Development Board.

During his study, he had a chance to take four workshops, the marine biology workshop at University of the Ryukyus at Japan, the seagrass workshop at University of the Philippines, the microBRIAN data integration workshop at Canberra and the microBRIAN intensive workshop at Townsville, Australia.
