BIOGRAPHY

The Hereditary Baron Otto von Feigenblat is the eldest son of the House of Feigenblatt-Miller. He was born in the peaceful country of Costa Rica in Central America but spent much of his infancy in Spain and the United States. The House of Feigenblatt-Miller has a long history of diplomatic service during which its members have served in the civil service of five nation-states, namely, the Russian Empire, the German Empire, the Kingdom of Spain, the Republic of Panama, and the Republic of Costa Rica. There he successfully completed a BA in Social Science after which he enrolled in the Master of Arts Program in International Development Studies at Chulalongkorn University in Thailand.

In addition to his studies, Otto von Feigenblatt, has been actively involved in the promotion of nobiliary organizations in Latin American and the United States. The Hereditary Baron is an Honorary Member of the Augustan Society in the United States and has served for many years as the president of the Association for the Defense of the French and International Nobility for Latin America and the United States. This is an association established in France for the purpose of supporting houses in exile and the interests of the international nobility. In addition to that the Hereditary Baron is an active member of several orders of knighthood and has helped organize philanthropic events with their support.
