This template is intended for registering domains in the TH domain only.
Only domestic organizations will be allowed to request for domain under TH.

To establish a new domain, make changes to existing domain name records or remove a domain name from the TH domain, complete and send the attached form via e-mail to DOMREG@THNIC.NET. Please do not send hardcopy registrations to the THNIC. Your provider will be able to send e-mail applications for you if you are not connected. In the Subject of the message, use the words "NEW DOMAIN", "MODIFY DOMAIN", "DELETE DOMAIN", or "TRANSFER DOMAIN" appropriately, followed by the Domain name to help sort and locate incoming registration requests.

For example,

Subject: MODIFY DOMAIN chula.ac.th

Because THNIC applications are machine processed, application forms *MUST* be submitted in plain ASCII, do not use MIME encoding unless that MIME encoding can be viewed without any form of decoding. In particular, do not encode your application using BASE64 encoding techniques. In addition, DO NOT attempt to format your application in any fashion, e.g., do not justify text, delete or insert extra blank lines between lines in a template. Failure to observe these restrictions will likely result in syntax errors being returned to you as the automated parsing system is not prepared to handle significant deviations from the format presented in the form below.

Section 1 - Registration Action Type

To register a new domain, place the character "N".

To modify information about an existing domain, place the character "M".

To delete an existing domain, place the character "D".

For example, for registering a new domain:

--> 1. (N)ew (M)odify (D)elete...: N

NOTE: Changing a name from DOMAINAME1 to DOMAINAME2 is treated as a New registration. The transfer of a name from one organization to another is also treated as a New registration.

Section 2 - Complete Domain Name

Enter the complete domain name you wish to register, this name MUST come from the name or the initial letter of organization using it, If all those names have been used, then it can be any reasonable name subject to approval of THNIC staff.

The only characters allowed in a domain name are letters, digits and the dash (-). A domain name cannot be all numbers and cannot begin or end with a dash (see RFC952).

For example,

--> 2. Complete Domain Name.....: chula.ac.th

The following will help you determine the most appropriate second-level domain to join. Briefly:

ac.th is for academic institutions or universities
 co.th is for commercial, profit-oriented organizations
 go.th is for government agencies
 net.th is for network service provider organizations
 or.th is for miscellaneous usually non-profit organizations

Section 3 - Organization Description

Briefly describe the organization, type of business. You may add as many lines as necessary for your organization description.

Section 4 - Administrative Contact & Organization using Domain Name

The domain name is considered to be registered to an organization. THNIC policy is that the administrative contact MUST be an employee of the organization requesting this domain name who can speak on behalf of this organization. This person should be able to answer non-technical questions about the organization's plans for the name, and procedures for establishing sub-domains, and should be able to represent the organization regarding use of the name.

Item 4a. NIC handle

If the person's NIC handle is known, insert just the handle in item 4a and leave the rest of Section 4 blank.

If the person's NIC handle is unknown, leave item 4a blank.

Please note that only NIC handle assigned by THNIC or APNIC can be used in this form.

Item 4d. Address

At least one line of address information is REQUIRED in item 4d. You may add as many lines as necessary for your address.

For example,

--> 4d. Address.....: 31/5 Soi. Phirom
 Songwad Rd. Jakawad
 Sampanthawong

Item 4g. Country code

Enter the ISO3166 two-letter country code.

For example, for thailand:

--> 4g. Country Code.....: TH

Item 4h. Phone Number; 4i. Fax Number

Use international standard phone/fax number format. Likewise, you may add as many lines as necessary for your phone/fax numbers. Please do not put different phone/fax numbers in the same line except those that can be written in a continuous block format.

For example,

--> 4h. Phone Number.....: +66-2-2782924-6 ext. 112
 +66-2-2452060
 --> 4i. Fax Number.....: +66-2-2782910

Item 4j. E-Mail

Enter e-mail address of the contact.

For example,

--> 4j. E-Mail.....: user@your.domain.

NOTE: Administrative contact MUST include telephone number (4h) and e-mail address (4j).

Section 5 - Technical Contact

The technical contact is the person who tends to the technical aspects of maintaining the domain's name server, resolver software, and database files. This person keeps the name server running, and interacts with technical people in other domains to solve problems that affect the domain. The Internet Service Provider often performs this role.

The procedures for completing Section 5 are the same as for Section 4.

NOTE: Technical contact MUST include telephone number (5h) and e-mail address (5j). Administrative contact and technical contact MUST not be the same person.

Section 6 - Primary Name Server

Please provide the fully-qualified name and network address of the machine that is to be the primary name server.

For example,

Section 7 - Secondary Name Server(s)

The procedures for completing Section 7 are the same as for Section 6. At least one secondary name server is required. If multiple secondary servers are desired, you can have up to three secondary servers.

NOTE: Domains MUST provide at least two independent servers for translating names to addresses for hosts in the domain. The servers should be in physically separate locations and on different networks if possible. The servers should be active and responsive to DNS queries BEFORE this application is submitted. Incomplete information in Sections 6 and 7 or inactive servers will result in delay of the registration.
