#### CHAPTER III

# FEYNMAN PATH INTEGRAL APPROACH TO THE POLARON AT ABSOLUTE ZERO TEMPERATURE

In this chapter, we shall present the detailed evaluation of the polaron ground state energy at absolute zero temperature by using the Feynman path integration approach. The original idea of this formulation was given by Feynman (6) in 1954.

### III.1 Elimination of the Field Coordinates

Consider the Fröhlich idealized polaron model introduced in Chapter I and the classical Lagrangian of the system (1.20) which is given by

where  $P_{ir}(r)$  is the polarization field induced by the electron, which is implicitly dependent on the position vector  $rac{r}_{el}$ . The constant 7 depends on the frequency  $\omega_L$ , and the static and high frequency dielectric constants  $\epsilon_s$  and  $\epsilon_\infty$ , as follows

 $\mathbb{D}(Y,Y_{el})$  is the dielectric displacement arising from the electronic charge, as defined by (1.3).

For simplicity,  $P_{ir}(r)$  is replaced by a Fourier

which consists of the three components arising, respectively, from the electronic part, the lattice vibrational modes and the electron-lattice interaction. With the condition that the lattice vibrational modes are each coupled only to the electron, and not to the other modes, we can write the Lagrangian of the arbitary mode for any given path of the electron  $\Gamma_{el}(\bar{t})$  separately as

Obviously,  $L_{\underline{k}}$  is the Lagrangian for a forced harmonic oscillator comparable with the Lagrangian (2.8), for which the classical action, including the propagator, has been provided in Section II.2.

Furthermore, it is justifiable to represent the polaron system by a system of independent harmonic oscillators with coordinates  $\phi_k$  and action  $S_o$ , each oscillator interacting with an electron with action  $S_{el}$  through the Lagrangian  $\phi_k(t) \Gamma_k(t)$  and the action

If at some time t"the electron is at  $\underline{r}''_{el}$ , and the oscillators are in the eigenstate  $Q_m$ , when at a previous time t'the electron was at  $\underline{r}'_{el}$  and the oscillators were in the eigenstate  $Q_n$ , the propagator can then be written as

In general, the problem concerning an interaction of matter and field can be solved easily by first eliminating the field variables from the equation of motion of the matter so that the behaviour of the matter can then be discussed separately. Such a formulation has been found to be very useful in solving quantum electrodynamical problems. (20)

For the polaron system, it is also possible to integrate the field coordinates of the oscillator part from the system, and then we can concentrate our interest on the

behaviour of the electron alone. This is the advantage acquired through using a Lagrangian form of quantum mechanics to describe the polaron. Here, we are going to integrate the paths of the oscillators out by expressing the propagator in two parts as

As the polaron state under consideration is at absolute zero temperature, all oscillators are in their ground states initially and also finally. Therefore the propagator of each oscillator,  $G_{oo}^{\&}$ , is given by

where our units are such that  $\overline{h}\omega_{\underline{L}}$  and the effective mass m\* are unity.

The polaron action after the phonon field is averaged, is given by the above equation as

which describes the electron at any particular time interacting with the produced field at a past time as a retarded, nonlocal coulomb potential with exponentially decaying time factor.

The disturbance that acts back on the electron in the past time dies out since it takes some time for the lattice ions to relax.

## III.2 Variational Principle

The polaron action after the phonons of the lattice field have been averaged is given by (3.35) as

S =

where the time variables 7 and dare now replaced by t and s.

It is difficult to evaluate the path integration of this action which is not quadratic in  $\underline{r}$  and  $\dot{\underline{r}}$ , since only quadratic actions will lead to integrable path integrals.

To determine the polaron ground state energy, an action which is simple, integrable, and imitates the action in rough approximation, must be supposed, and then the variational method

can be applied.

Feynman introduced the trial action in the form of

$$S_1 = -\frac{1}{2} \int \left(\frac{dkel}{dt}\right)^2 dt - \frac{c}{2} \int \int dt ds \left| \frac{r}{rel}(t) - \frac{r}{rel}(s) \right|^2 e^{-\omega |t-s|}, \qquad (3.37)$$

where the kinetic energy part is the same as that of the exact action (3.36) and the potential energy part resembles the harmonic oscillator potential with the strength and frequency which can be varied by the two adjustable parameters  $\zeta$  and  $\omega$ .

Now consider

This is the <u>variational principle</u>, which provides an upper bound on the exact ground state energy. The problem is thus to determine  $E_1$ —Mand then to minimize it by means of the adjustable parameters C and  $\omega$ .

## III.3 Ground State Energy

In order to evaluate an upper bound to the ground state energy, we must determine both  $\mathbf{E}_1$  and  $\boldsymbol{\delta}$ . Let us consider first

$$A = \frac{2}{2^{3/2}} \int_{0}^{3} ds e^{-|t-s|} \left\langle \frac{1}{|r_{e|}(t) - r_{e|}(s)|} \right\rangle , \quad (3.44a)$$

$$B = \frac{c}{2} \int_{0}^{b} ds e^{-\omega(t-s)} \left\langle |r_{el}(t) - r_{el}(s)|^{2} \right\rangle . \quad (3.44b)$$

We are concerned with the imaginary time, initially at t'=0, and finally at  $t''=\frac{1}{2}$  which is very large.

Our first object is to determine the A term of (3.44a). In it we can express  $\frac{1}{|f_{el}(t)-f_{el}(5)|}$  by a Fourier transform,

$$\frac{1}{\left|\frac{d^{3}K}{r_{el}(\tau)-r_{el}(6)\right|}} = \int \frac{d^{3}K}{2\pi k^{2}} \exp\left[i\frac{K}{\kappa}.\left(r_{el}(\tau)-r_{el}(6)\right)\right]. \quad (3.45)$$

Then we need to study  $\left\langle \exp\left[i \underbrace{\mathbb{K} \cdot (\underline{r}_{el}(\tau) - \underline{r}_{el}(\sigma))}^{\mathbf{S}}\right] \right\rangle = \frac{\int \underbrace{\mathcal{S}}_{el}(t) e^{s_{!}} \exp\left[i \underbrace{\mathbb{K} \cdot (\underline{r}_{el}(\tau) - \underline{r}_{el}(\sigma))}^{\mathbf{S}}\right]}{\int \underbrace{\mathcal{S}}_{el}(t) e^{s_{!}}} \\
= \int \underbrace{\mathcal{S}}_{el}(t) \exp\left[-\frac{1}{2} \int \left(\frac{d\underline{r}_{el}}{dt}\right)^{2} dt - \frac{c}{2} \int dt ds |\underline{r}_{el}(t) - \underline{r}_{el}(\sigma)|^{2}}_{\mathbf{x}e^{-\omega t} - \mathbf{s}^{-\omega t}} + \int \underline{f}(t) \cdot \underline{r}_{el}(t) dt \right], (3.46)$ 

where  $f(t) = i k (\delta(t-t) - \delta(t-6))$ , and where a normalization factor is dropped out.

Since the three rectangular components of (3.46) can be separated, we need to consider only one component, say the x-component. Therefore (3.46) is reduced to

$$\left\langle \exp\left[iK_{x}\left(X(\tau)-X(6)\right)\right]\right\rangle = \int \mathcal{D}X(t) \exp\left[-\frac{1}{2}\int\left(\frac{dx}{dt}\right)^{2}dt - \frac{c}{2}\int\int dt ds\left[X(t)-X(5)\right]^{2},$$

$$e^{-\omega_{1}t-s_{1}} + \int f_{x}(t) X(t) dt\right]. \quad (3.47)$$

The path integration of (3.47) can be carried out by substituting for x(t) the classical path  $\overline{x}(t)$  and its variation y(t), and by using the method described in Section II.2. The result can be separated into two parts, viz., the terms that are directly dependent on the classical path, and the integration terms of y(t) that give an unimportant constant depending on T only. Then we obtain

The action corresponding to this expression can be written as

$$S = -\frac{1}{2} \int \left(\frac{d\bar{x}}{dt}\right)^2 dt - \frac{c}{2} \int \int dt ds \left[\bar{x}(t) - \bar{x}(s)\right]^2 e^{-\omega |t-s|} + \int f(t)\bar{x}(t) dt. \quad (3.49)$$

The classical path  $\bar{x}(t)$  is given by that function which satisfies the principle of least action  $\delta S=0$ .

Hence

$$\begin{split} \delta s &= -\frac{1}{2} \int_{2} \left( \frac{d\overline{x}(t)}{dt} \right) \delta \dot{\overline{x}}(t) dt - \frac{c}{2} \iint_{2} dt ds \, 2 \left[ \overline{x}(t) - \overline{x}(s) \right] e^{\omega (t-s)} \delta \left[ \overline{x}(t) - \overline{x}(s) \right] \\ &+ \int_{2} f_{x}(t) \, \delta \dot{\overline{x}}(t) \, dt \\ &= \int_{2} \left[ \frac{d^{2} \overline{x}(t)}{dt^{2}} - 2c \int_{2} ds \left[ \overline{x}(t) - \overline{x}(s) \right] e^{\omega (t-s)} + f_{x}(t) \right] \delta \overline{x}(t) dt = 0 \end{split}$$

which gives the equation of motion for the classical path

$$\frac{d^2\bar{x}(t)}{dt^2} = 2c \int ds [\bar{x}(t) - \bar{x}(s)] e^{-\omega 1t - sI} - f_x(t) , \qquad (3.50)$$

under the boundary conditions  $\overline{\mathbf{x}}(0) = \overline{\mathbf{x}}(\mathring{\mathcal{S}}) = 0$  which are chosen for convenience.

Thus (3.48) can be simplified by using (3.50) to

$$\left\langle \exp\left[iK_{x}\left(x(\tau)-x(6)\right)\right]\right\rangle = \exp\left[-\frac{1}{2}\frac{d\bar{x}(t)}{dt}.\bar{x}(t)\right]_{o}^{\int_{0}^{\infty}+\frac{1}{2}\int\frac{d^{2}\bar{x}(t)}{dt^{2}}.\bar{x}(t)dt} 
-\frac{c}{2}\int\int_{0}^{\infty}dtds\left[\bar{x}(t)-\bar{x}(5)\right]^{2}e^{-\omega |t-5|}\int_{0}^{\infty}f_{x}(t)\bar{x}(t)dt 
= \exp\left[\frac{iK_{x}}{2}\left(\bar{x}(\tau)-\bar{x}(6)\right)\right] , \quad (5.51)$$

To obtain the above quantity, we must solve the equation of motion (3.50) and substitute  $\bar{x}(\tau)$  and  $\bar{x}(6)$  into (3.51). To do this we define

$$Y(t) = \frac{\omega}{2} \int e^{-\omega |t-s|} \chi(s) ds \qquad (3.52)$$

Then the classical path equation of motion (3.50) can be written in the form involving y(t) as

$$\frac{d^2\bar{x}(t)}{dt^2} = \frac{4c}{\omega} \left[ \bar{x}(t) - Y(t) \right] - f_x(t) , \qquad (3.53)$$

where we have substituted  $\int ds e^{-\omega |t-s|}$  by  $\frac{2}{\omega}$ , the validity of which assumption will be discussed in Chapter VI.

By performing the second order differentiation with respect to time t on (3.52), we obtain the differential equation of Y(t) as

$$\frac{d^2Y(t)}{dt^2} = \omega^2 \left[ Y(t) - \overline{X}(t) \right] \qquad (3.54)$$

It is desired to eliminate the Y(t) term in (3.53) in order to convert the classical path integro- differential equation into an ordinary differential equation. To do this, we multiply(3.53) by  $\omega(D^2-\omega^2)$  ( where  $D=\frac{d}{dt}$  ), whereupon we obtain

$$D^{2}(D^{2}-V^{2})\bar{x}(\dagger) = -(D^{2}-\omega^{2})f_{x}(\dagger) , \quad (3.55)$$

where we have used

$$V^2 = \omega^2 + \frac{4C}{\omega} \qquad (5.56)$$

Finally, we can solve for the classical path  $\bar{x}(t)$  in the ordinary fourth order differential equation (3.55) by applying Laplace transform.

Thus Eq. (3.55) becomes  $P^{4} f(p) - P^{3} \bar{x}(0) - P^{2} \dot{x}(0) - P \ddot{x}(0) - \ddot{x}(0) = - \int_{0}^{e^{-p^{+}}} e^{-p^{+}} (D^{2} - \omega^{2}) f_{x}(\bar{t}) dt . (3.57)$   $= - \sqrt{2} (p^{2} f(p) - P \bar{x}(0) - \dot{x}(0))$ 

The transient terms in the solution at the end points can be neglected, since the time interval  $(0, \frac{3}{2})$  is very large and most of the contribution is certainly not from here. Then (3.57) is reduced to

$$P^{2}(P^{2}-V^{2}) f(P) = -i K_{x} \int_{P^{2}-V^{2}}^{\infty} e^{-P^{T}} (D^{2}-\omega^{2}) (\delta(t-\tau)-\delta(t-\delta)) dt$$

$$f(P) = -i K_{x} (e^{-P^{T}-P^{C}}) + \frac{i K_{x} \omega^{2} (e^{-P^{T}-P^{C}})}{P^{2}(P^{2}-V^{2})}. (3.58)$$

The classical path can be obtained directly from (3.58) by taking inverse Laplace transform. The result is that

$$\overline{X}(t) = -i\frac{Kx}{v} \left[ \sinh v (t-z) H (t-z) - \sinh v (t-6) H (t-6) \right]$$

$$+ i\frac{Kx}{v^3} \left[ \sinh v (t-c) H (t-c) - \sinh v (t-6) H (t-6) \right]$$

$$- i\frac{Kx}{v^2} \left[ (t-c) H (t-c) - (t-6) H (t-6) \right] \cdot (5.59)$$

Now  $\bar{x}(t)$  must satisfy the following boundary condition:

$$\bar{X}(\hat{J}) = 0 = \left(-\frac{iKx}{v} + \frac{iKx}{v^3}\right) \left[\sinh(\hat{J}-\tau) - \sinh(\hat{J}-\delta)\right]$$

$$-\frac{iKx\omega^2}{v^2} \left[(\hat{J}-\tau) - (\hat{J}-\delta)\right].$$

As 3 approaches ∞,

$$= -\left(-\frac{i K_x}{V} + \frac{i K \omega^2}{V^3}\right) \left[2\cosh \frac{V}{2}(2\delta-\tau-\delta)\sinh \frac{V}{2}(\tau-\delta)\right] - 0 ,$$

whereupon we obtain a condition

• 
$$\sinh \frac{V}{2}(\tau - 6) = 0$$
 or  $\cosh V(\tau - 6) = 1$  . (3.60)

By using (3.59), Eq. (3.51) leads to

$$\langle \exp \left[ i \, K_{X} (X(\tau) - X(\delta)) \right] \rangle = \exp \left[ -\frac{2c \, K_{X}^{2}}{V^{3} \omega} (\cosh V \, | \tau - \delta] - \frac{V(\tau - \delta)}{2 \, V^{2}} \right] - \frac{K_{X}^{2} \omega^{2}}{2 \, V^{2}} |\tau - \delta|$$

$$= \exp \left[ -\frac{2c \, K_{X}^{2}}{V^{3} \omega} (1 - e^{-V(\tau - \delta)}) - \frac{K_{X}^{2} \omega^{2}}{2 \, V^{2}} |\tau - \delta| \right], (3.61)$$

so that

$$\left\langle e \times p\left[i \frac{K}{\kappa} \cdot \left(\frac{r}{\kappa_{el}}(t) - \frac{r}{\kappa_{el}}(s)\right)\right] \right\rangle = e \times p\left[-\frac{2c\kappa^2}{V^3\omega}\left(1 - e^{-V|t-s|}\right) - \frac{\kappa^2\omega^2}{2V^2}\left(1 - s|\right)\right].$$
 (3.62)

We have obtained the result that is correctly normalized, since it is certainly valid for  $\underline{K}=0$ . Now we can determine the A term by substitution of (3.62) and (3.45) into (3.44a), thus

$$A = \frac{\frac{c}{2^{3/2}} \int_{0}^{\infty} ds \, e^{-1t-st} \int_{-\infty}^{\infty} \frac{d^{3}K}{2\pi^{2}K^{2}} \exp\left[-\frac{2cK^{2}}{V^{3}\omega} \left(1-e^{-Vt-st}\right) - \frac{K^{2}\omega^{2}}{2V^{2}} \right] + st}$$

$$= \frac{cV}{\pi^{1/2}} \int_{0}^{\infty} d\tau \, e^{-\tau} \left[ \frac{(V^{2}-\omega^{2})}{V} \left(1-e^{-V\tau}\right) + \omega^{2}\tau \right]^{-\frac{1}{2}} . (5.63)$$

Our next purpose is to find B; therefore we need the value of  $\langle | \chi_{el}(^{\dagger}) - \chi_{el}(^{\varsigma})|^2 \rangle$ . To obtain this we apply second order differentiation with respect to  $K_{\chi}$  to (3.61), and then take the limit  $K_{\chi}$  to zero, thus

$$\langle | r_{el}(t) - r_{el}(s) |^2 \rangle = 3 \langle (x(t) - x(s))^2 \rangle = \frac{12C}{v^3 \omega} (1 - e^{-v|t-s|}) + \frac{3\omega^2 |t-s|}{v^2} (3.64)$$

The B term can now be easily integrated out by using (3.64). The result is

$$B = \frac{3C}{v\omega}, \qquad (3.65)$$

where we have used the equality  $\int_{0}^{\infty} e^{-a|t-s|} ds = \frac{2}{a}$ , for any arbitary a which is independent of s, in performing the integration.

The final object is to evaluate the ground state energy  $E_1$  that corresponds to the trial action  $S_1$ . To effect this, we recall (3.41)

$$\int \mathcal{D} r_{el}(t) e^{S_i} \sim e^{-E_i S}.$$

After differentiating both sides of this equation, we obtain

$$\frac{\frac{1}{2}\int \mathcal{D} r_{el}(t) e^{s_{i}} \left[ \int dt ds \left[ r_{el}(t) - r_{el}(s) \right]^{2} e^{-\omega |t-s|} \right]}{\int \mathcal{D} r_{el}(t) e^{s_{i}}} = \frac{\int dE_{i}}{dc}$$

$$\frac{3}{V\omega} = \frac{dE_{i}}{dc} . (3.66)$$

By substituting dC obtained from (3.56) into the above equation, it follows that

$$dE_1 = \frac{3}{2} dV + 3 \frac{(V^2 - 3\omega^2)}{4V\omega} d\omega. \qquad (3.67)$$

Comparing (3.67) with

$$dE_{i} = \frac{\delta E_{i}}{\delta v} dv + \frac{\delta E_{i}}{\delta \omega} d\omega ,$$

we obtain

$$\frac{\delta E_1}{\delta V} = \frac{3}{2}$$

and hence

$$E_1 = \frac{3}{2}V + f(\omega)$$
 (3.68)

By using the condition  $E_1=0$  when C=0, we can find  $f(\omega)$  explicitly as  $3\omega$ . Therefore, the ground state energy  $E_1$  can be determined, i.e.,

$$E_1 = \frac{3}{2} (v - \omega)$$
 (3.69)

Finally, the expression for the upper-bound of the ground state energy can be evaluated by employing the results that are readily determined from (3.44), (3.63), and (3.65). We obtain

$$E = E_1 - x^2 = \frac{3}{2} (V - \omega) - \frac{3}{V} (\frac{V^2 - \omega^2}{4}) - A$$

$$= \frac{3}{4V} (V - \omega)^2 - A \qquad , \qquad (3.70)$$

where A is given by (3.63).

We remark that the adjustable parameters C and  $\omega$  are now replaced by v and  $\omega$  which can be varied separately to minimize E. The complete evaluation of E requires numerical integration of A, which cannot be performed in closed form. The numerical work has been carried out by Schultz by using a digital computer. He has calculated the values of v,  $\omega$  and E for several values of  $\alpha$ , and his results will be presented in Chapter VII.
