### **CHAPTER III**

## MODELING OF GRID-CONNECTED PHOTOVOLTAIC SYSTEM

### 3.1 Photovoltaic Modeling




Figure 3-1 The equivalent circuit of the PV cell model

For this research work, a model of moderate complexity was used based on [16], [17] and shown in figure 3-1. The model includes temperature dependence of the photo-current  $I_{ph}$  and the saturation current of the diode  $I_o$ . A series resistance  $R_s$  was included, but not a shunt resistance. A single shunt diode was used with the diode quality factor set to achieve the best curve match.

The equations which describe the I-V characteristics of the cell are as follows:

The photo-current  $I_{ph}$  is directly proportional to irradiance  $G_a$ . When the cell is shortcircuited, current flow in the diode is negligible. Hence the proportionality constant in equation 3-3 is set so the rated short-circuit current Isc is delivered under rated irradiation. The relationship between the photo-current and temperature is linear shown in equation 3-2 and is reduced by noting the change of photo-current with the change of temperature as shown in equation 3-4. When the cell is not illuminated, the relationship between the cell's terminal voltage and current is given by the Shockley equation. When the cell is open circuited and illuminated, the photo-current flows entirely in the diode. The I-V curve is offset from the origin by the photo generated current  $I_{ph}$  shown in equation 3-1. The value of the saturation current  $I_0$  at 25 °C is calculated using the open circuit voltage and short-circuit current at this temperature shown in equation 3-6. The relationship of  $I_0$  to temperature is more complex, but fortunately it contains no variables requiring evaluation shown in equation 3-5. The value of diode quality factor n depends on the material type of photovoltaic cell; it is between 1 and 2. In generally, the value of diode quality factor n=2 for crystalline silicon and n < 2 for amorphous silicon PV cell. However, an estimate must be made of this unknown parameter. A value of 1.2 is suggested as typical in normal operation of the model validation for the 80W Sharp PV module. This value may be used initially until a more accurate value is estimated later through curve fitting.

For the series resistance  $R_s$  of PV cell, it can be obtained using only manufacturer supplied data for the PV modules at standard test conditions (STC), such as open-circuit voltage  $V_{oc}$ , short-circuit current  $I_{sc}$  and maximum power  $P_m$ . The equations which are used to evaluate the value of  $R_s$  are presented as following [18], [19]:

Since cells vary in temperature not only because ambient temperatures change, but also because irradiation on the cells changes. To help the researcher account for changes in cell performance with temperature, manufacturers often provide a normal operating cell temperature (NOCT) indicator where NOCT is cell temperature in a module when ambient is 20 °C, solar irradiation is 800 W/m², and wind speed is 1 m/s. The value of NOCT for modules currently on the market varies from about 42 to

46 °C [6]. To account for other ambient conditions, the following equation may be used [2]:

Normally, cells are grouped in to "modules", which are encapsulated with various materials to protect the cells and the electrical connectors from the environment. The manufacturers supply PV cells in modules, consisting of  $N_{PM}$  parallel branches, each with  $N_{SM}$  solar cells in series. In order to develop the PV module model, the cell output voltage  $V_{pv}$  is then multiplied by the number of the cells connected in series  $N_{SM}$  to calculate the full module voltage  $V^M$ , they all have the same voltage in each parallel branches. In the same way, the cell output current  $I_{pv}$  is then multiplied by the number of branches connected in parallel  $N_{PM}$  to obtain the full module current  $I^M$ , they all carry the same current in series each branches.

#### 3.2 Implementation in MATLAB-SIMULINK




Figure 3-2 Implementation of PV characteristic modeling in SIMULINK




Figure 3-3 PV characteristic modeling forming in block diagram

SIMULINK is a simulation program, which provides a graphical interface for building models as blocks diagrams. It offers to build hierarchical models, to view the system at different levels, and be able to build modular models which can be easily connected together system in order to do the simulation. From the section 3.1, the mathematic equations for PV characteristic modeling could be implemented in MATLAB-SIMULINK shown in figure 3-2 and form into block diagram in figure 3-3.

The PV model developed in MATLAB-SIMULINK is used to simulate I-V and P-V characteristics. There are four important inputs: 1) irradiance and cell temperature, 2) the number in series and parallel of PV modules to scale up the output power, 3) voltage, and 4) current required in PV model design which contains necessary equations listed in section 3.1 to calculate the cell current Ipv and establish the I-V characteristic and also P-V characteristic curve by changing the terminal output cell voltage  $V_{pv}$ .




Figure 3-4 I-V characteristic with constant ambient temperature and various irradiances




Figure 3-5 P-V characteristic with constant ambient temperature and various irradiances




Figure 3-6 I-V characteristic with constant irradiance and various ambient temperatures

Figures 3-4 and 3-5 illustrate the example of I-V characteristic and P-V characteristic with constant ambient temperature and some various irradiances from 250-1000 W/m<sup>2</sup> of 80W Sharp PV module shown in Table 3-1. Figures 3-6 and 3.7 illustrate I-V and P-V characteristic while the irradiance is constant at 1000 W/m<sup>2</sup> and some various ambient temperatures from 0-75 °C.




Figure 3-7 P-V characteristic with constant irradiance and various ambient temperatures

Figure 3-4 shows that the open-circuit voltage increases logarithmically with the ambient irradiation, while the short-circuit current is a linear function of the ambient irradiation. Figure 3-6 is the influence of the cell temperature on the I-V characteristic; increasing cell temperature will linearly decrease of the open-circuit voltage, the cell being thus less efficient while the short-circuit current slightly increases with cell temperature.

In order to test the PV model, some results are carried out by verifying with the actual work supported by National Science and Technology Development Agency (NSTDA) of Thailand. I-V Checker MP-140 shown in figure 3-8 and other three meters are used to measure the characteristic of Sharp PV module as shown in table 3-1. The sun irradiance, ambient temperature, and the voltage from the PV module are recorded by a pyranometer, thermometer, and voltmeter respectively.

Table 3-2 illustrates the comparison result between the PV model simulation and those measured from the IV-Checker MP-140 at high irradiance, 1025.3 W/m<sup>2</sup> and temperature at 36.4 °C, medium irradiance, 600.6 W/m<sup>2</sup> and temperature at 30.91 °C,

and low irradiance, 205.1 W/m<sup>2</sup> and temperature at 33.80 °C. Model results agree rather well with actual measurements. Figures 3-9, 3-10 and 3-11 are the I-V and P-V characteristic of Sharp PV module that measured from I-V Checker MP-140 and simulates in MATLAB-SIMULINK, at irradiance, 600.6 W/m<sup>2</sup> and temperature at 30.91 °C respectively.




Figure 3-9 I-V and P-V characteristic with  $G_a = 600.6 \text{ W/m}^2$ , and  $T_a = 30.91 \text{ °C}$ 




Figure 3-10 I-V characteristic with  $G_a = 600.6 \text{ W/m}^2$ , and  $T_a = 30.91 \,^{\circ}\text{C}$ 




Figure 3-11 P-V characteristic with  $G_a = 600.6 \text{ W/m}^2$ , and  $T_a = 30.91 \text{ °C}$




Figure 3-12 Boost converter diagram in SIMULINK




Figure 3-13 P&O MPPT algorithm in SIMULINK

From section 2.3.1, boost converter can be implemented in SIMULINK as shown in figure 3-12. The ideal switch is operated by the pulse signal from the P&O MPPT algorithm shown in figure 3-13.

From figure 3-13, the MPPT will find the operation point by tracking the power that measure from the PV module. Then, it creates the pulse signal to control the boost converter by comparing the duty cycle value with the ramp signal.




Figure 3-14 Voltage regulator in SIMULINK

The IGBT inverter uses pulse width modulation (PWM) at a 2 kHz carrier frequency. The load voltage is regulated at 1 pu (380 V rms) by a PI voltage regulator using abc\_to\_dq0 and dq0\_to\_abc transformations shown in figure 3-14. The output of the voltage regulator is a vector containing the three modulating signals used by the PMW generator to generate the 6 IGBT pulses. The harmonics generated by the inverter around multiples of 2 kHz are filtered by the LC filter.




Figure 3-15 23-bus distribution system in Thailand

The GCPV is connected to the distribution system through a step up transformer from 380 V to 22KV. Figure 3-15 [20] is a radial distribution system in Thailand containing 23 buses with 700kW load. There are some protective devices like circuit breaker at the subsystem, recolser, cut off fuse to protect the system when the fault occurs. To investigate the impact of the fault current in the presence of DG, the system is modified into 23-bus 22kV, 65MVAsc distribution system with the total load of 700kW shown in appendix B.





Figure 3-16 Modeling Grid-Connected PV in MATLAB-SIMULINK

As the result, the GCPV model shown in figure 3-16 is implemented in MATLAB-SIMULINK, containing PV array, boost converter with maximum power point tracking, PWM inverter with voltage regulator, step up transformer, and 23 buses distribution system. The PV array could be able to form in any power ratings depend on the input number in series and parallel of the module.




Figure 3-18 Output current of the PV array




Figure 3-19 Output voltage of the inverter with the load change at t=0.15s




Figure 3-20 Output current of the inverter with the load change at t=0.15s




Figure 3-21 Output power of PV and inverter with the load change at t=0.15s

To test the GCPV model and its controller, the stand alone operation is proposed with load changing. The 70kW PV array is used for simulation with the load changing from half to full load (70kW) to show the performance of the systems. The simulation time is from 0 to 0.3s where the load changes at 0.15s. Figures 3-17 and 3-18 are the voltage and current at the terminal of the PV array. Figures 3-19 and 3-20 are the voltage at 1.0 p.u or 380 V and current at the terminal of the inverter. Figure 3-21 is the comparison between the output power at PV array and inverter side when the load is changed. Figure 3.22 is the MPPT tracking curve, and figure 3.23 is the modulation index of the inverter.




Figure 3-23 Modulation index (ma) of the inverter with the load change at t=0.15s

Figures 3.19 and 3.20 illustrate how the voltage regulator works; it seems that the voltage is still 1 p.u although the load changes at 0.15s where figure 3-21 illustrates that the PV array can energize the maximum power to the system load with the help of MPPT even though the load is only half of load from 0-0.15s. Then figure 3.22 illustrates that from 0-0.05s the MPPT is tracking to find the maximum power operation point.
